## Commercial & Corporate Law

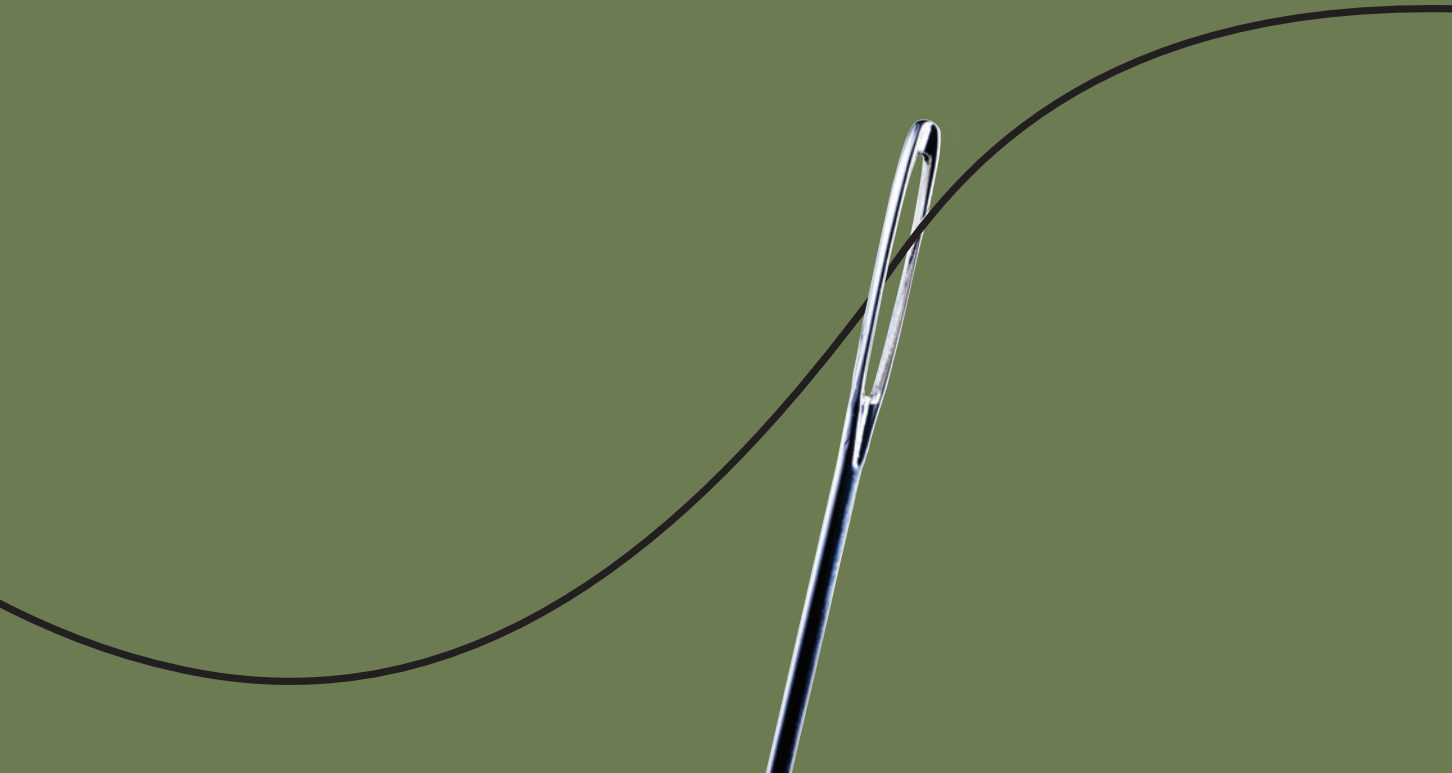

The activity of our IP division deals with all legal matters related to : patents, trademarks, industrial designs and models, domain names, copyright.

- conducting oppositions, contestations and cancellation proceedings;
- administrating and renewing trademarks;

- performing community trademark filings and registrations before the Office for the Harmonization in the Internal Market (OHIM);
- building trademark survey mechanisms against infringers;
- advising and representing clients in all the procedures related to trademark infringement, including drafting intervention petitions for the Customs Authorities;
- assisting in counterfeiting and unfair competition actions;
- negotiating the sale and acquisition of trademarks;
- drafting and reviewing complex agreements related to trademarks, including assignment, license, franchise and distribution agreements.

The survey service (for one trademark in one class) covers all the trademarks or trademark applications that are filed or protected on the Romanian territory (national registrations, international registrations and Community trademarks).

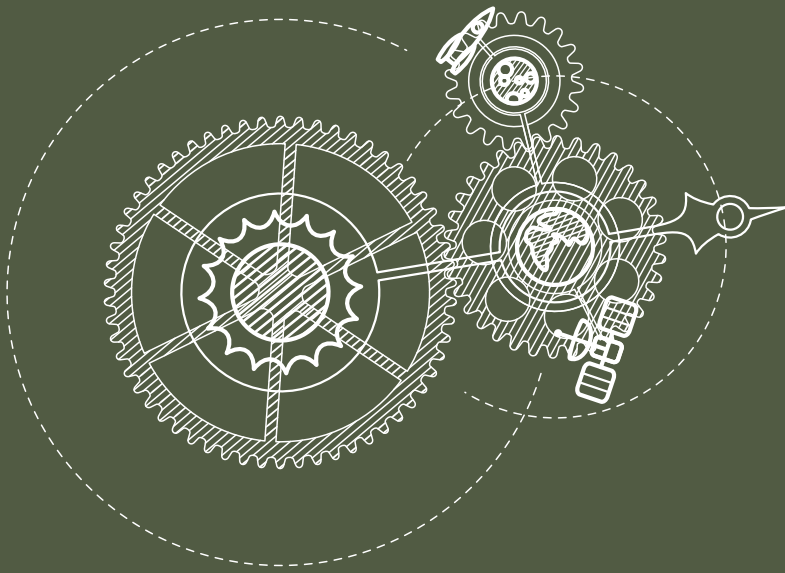
Also, upon request, we can provide information about new domain name registration (both gTLD and ccTLD) and corporate names registered with the Romanian Trade Register.

The provisions of the Romanian Trademark Law no. 84/1998 have changed recently, in order to make consistent the national legislation with the provisions of the European Parliament Directive no. 2008/95/CE dated October 22, 2008.

The new law came into force in Romania on May 9 2010 (Law no. 66/2010 amending and supplementing Law no. 84/998 regarding trademarks and geographical indications, published in the Official Gazette no. 226/09.04.2010).

Considering this very important change in the legislation, as well as the practical consequences of the implementation thereof over our clients' trademark portfolio, MILCEV BURBEA IP & Law Office has launched a reshaped trademark survey service, in order to keep them informed in a timely manner of potentially conflicting trademark applications covering Romania. It is advisable for the owners of anterior trademarks that are already registered or pending registration to ensure that no other person will register an identical or similar trademark by watching and surveillance constantly the Official Bulletin of Industrial Property, in order to be able to file an opposition within the 2 months period, if necessary.

Our expertise extends to all trademark-related commercial aspects such as labeling, packaging, consumer protection and advertising, to ensure that our clients products and services comply with the various governmental regulations.



## Patents

We offer services that cover all areas of patent protection and enforcement, extending beyond the traditional fields or combining other legal fields.

- drafting of patent specifications and application filing in Romania and European Patents;

- representing clients before the Romanian Custom Authorities, the Police and other state authorities in patent infringement procedures;

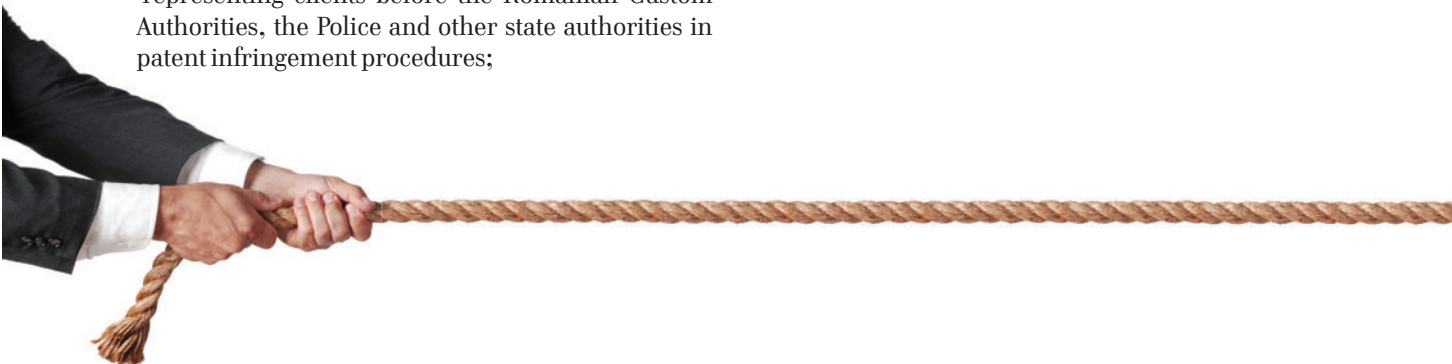
## Designs and Models

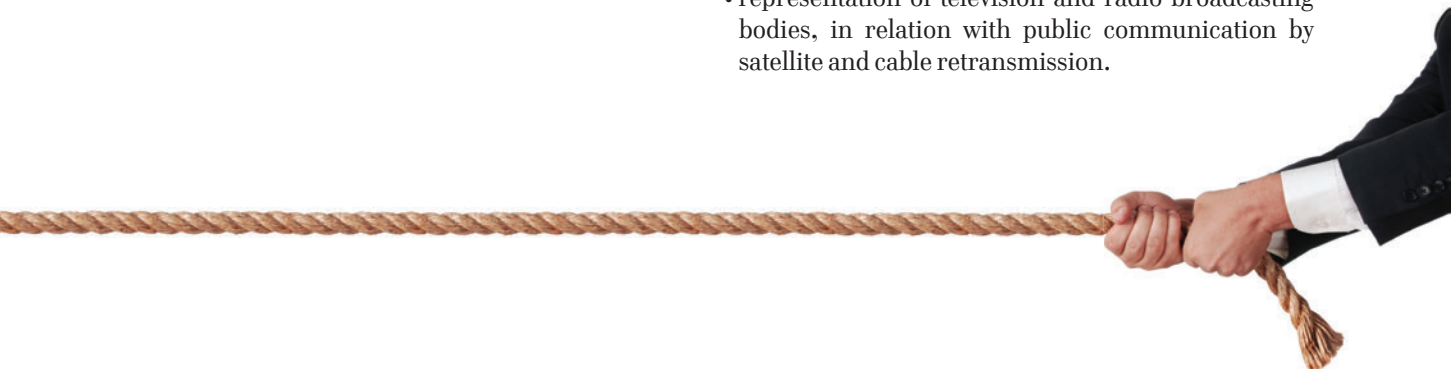
